Sitting down to work on this newsletter, I couldn't decide what to write about on the front page, so I took a look back at past June headlines. We've been through a lot!

In June 2011, "A Year Of Changes Comes To An End" reflected on the introduction of PLCs, APPR, and even the tax cap. In June 2013 we rallied in Albany against Race To the Top and the standardized testing industry. June 2014 brought the closing of AMS. June 2016's headline was "Relaxation, Recuperation, Registration", as the new protocols for maintaining certification were starting that July.

Welfare Trustees Update Coverage

The Welfare Trust Trustees recently met and voted on the following changes:

Changes to Dental Provider Network

Effective July 1, 2025, Dental Arts of the Hudson Valley will no longer be a Preferred Provider Organization (PPO) dentist for the Welfare Trust.

Members can still receive dental care at this practice, but the payment process will change. Members will pay for services at the time of treatment and then submit receipts for reimbursement according to our Fee Schedule rates. Reimbursement payments will be made directly to the member. Those who wish to switch dentists can find our Provider List at arlingtonteachers.com (on the Links & Forms page).

This change was made to ensure the financial sustainability of the Welfare Trust after several reports of overbilling and concerning patterns of billing were discovered. As a self-funded organization, we must carefully manage costs to protect benefits for all members.

The Trustees are also reviewing billing patterns from other high-cost providers to ensure responsible stewardship of Welfare Trust resources.

New Age Limits for Dependent Coverage

All child dependents enrolled in COBRA will now lose coverage on the last day of the month they turn 26 years old. Student dependents of active members will also now have coverage until age 26 (previously 25).

This aligns with Affordable Care Act standards and provides consistency across all dependent coverage policies. Current COBRA members affected by this change will receive individual notices. Surviving spouses of deceased members who receive COBRA benefits will not be impacted by this change.


Office Beautification Help Needed

Fix Tier Six!

The New York State Teachers' Retirement System and the New York State and Local Retirement System, which represents most school-related professionals, has six retirement tiers. Your tier membership is based on your hiring date. If you were hired on or after April 1, 2012, you're in Tier 6. Tier 6 requires public employees to work until age 63, up to 40 years, in order to retire without penalty.

Through NYSUT's advocacy, in 2024 the number of years required to vest in the pension system for Tier 6 members was reduced from 10 years to five years — the same amount required for Tier 4. As a result of that, more than 85,000 Tier 6 members became vested.

The fight continues. As part of their campaign to Fix Tier 6, NYSUT organized rallies across the state on the sixth of each month, the last

one being on 6/6 at the Walkway Over the Hudson. Despite a delayed start due to a strong thunderstorm, more than 500 union members from the Hudson Valley marched across the bridge from both sides and met in the middle to hear inspirational speeches from local union members, NYSUT President Melinda Person, and members of the NY State government who support the cause.




Retiree Author Offers Advice

Although AMS reading teacher Angela Calabrese has been retired since 2014, her students are still on her mind. Thinking about how it was often difficult to find books to captivate her reluctant readers, Calabrese decided to write her own stories. *Year of the Meatball*, her debut middle grade novel, launched in February of this year, and her first picture book, *The Precise Little Witch*, will be released in August.



The road to being a published author was no easy task, taking hours of research and a careful study of the market. Calabrese offers the following advice to aspiring children's writers:

- Read LOTS of books in the genre you're writing in, be it picture books, middle grade novels or early readers.
- Attend writer's conferences. Oftentimes, there are submission opportunities from the editors if you were an attendee, even if you don't have an agent. CWHV (Children's Writers of the Hudson Valley) is our local writer's group that organizes wonderful conferences every year. The next one will be held on November 8. They'll be posting details soon at www.cwhv.org.
- Join SCBWI (Society of Children's Book Writers and Illustrators). They are an organization that helps novice and seasoned writers improve their craft and network with other creatives. More information is at www.scbwi.org.
- Learn early on that rejections are a part of your writing journey. I could have wallpapered my family room with the amount of rejections I've received. If an agent or editor gives you some constructive feedback, that's considered gold. Consider their suggestions and if they resonate with you, revise accordingly.
- When your book is ready to find a home, study each publishing house's guidelines and follow them exactly. If they don't accept unagented

submissions, don't send your story unless you have an agent. Try to find an acquiring editor there and personalize your query letter to them (a query letter is a concise letter used by writers to pitch their book). If they only want to see the first five pages of your middle grade novel, don't send them 10. Show you are professional and capable of following instructions accurately.

- Don't give up. The kidlit world is a subjective industry. If you decided to call it quits after sending your story out to 49 places, who knows if the 50th one would have said YES?

Calabrese is excited to be visiting classrooms in the fall to talk about her books: "Don't be surprised if you see me roaming your school's hallway sporting a baseball cap or witch's hat!" More information about Calabrese and her books can be found at www.angecalabrese.com.
